Announcement Empire Life is pleased to announce that an extra 10% commission will be paid on all digital

deposits received and processed into Guaranteed Investment Funds (GIF) between January 1

and June 30th, 2020.

Eligible Products Only eligible GIF digital deposits will receive the commission bonus. GIF includes the following products:

- GIF 75/75
- GIF 75/100
- GIF 100/100

Digital deposits into Class Plus 3.0 or Empire Life legacy products will not be included.

GIF Digital Commission Bonus Rates

The GIF digital commission bonus will apply to the following purchase fee options:

^{*} Empire Life will pay a 0.25% deposit commission on all eligible GIF Front End Load deposits, regardless of the Front End Load percentage selected by the client

GIF Digital Commission Bonus eligibility

All Empire Life GIF digital deposits received and processed from January 1, 2020 through the end of business June 30, 2020, will receive the 10% commission bonus. This includes all deposits received through:

- Fast & Full Investment Application
- Empire Life Advisor Portal
- Fundserv Wire Order

[†] Any commissions in a Fee For Service contract are negotiated by the client and the Advisor/Dealer and are paid by the client directly

GIF Digital Commission Bonus calculation & payment

The 10% GIF digital commission bonus for all eligible deposits will be calculated at the end of each quarter, beginning March 31, 2020, and paid in a subsequent Empire Life weekly advisor pay period.

GIF digital commission bonuses will be paid to the advisor and MGA/Dealer directly and not through Fundserv. The 10% commission bonus for each purchase fee option will be paid in accordance with the following table.
