- If you are completing this form with your advisor, you must present an original piece of government issued identification to your advisor for verification of your residency status. Acceptable forms of identification include a driver's licence or passport.
- If you are not completing this form with your advisor, you must provide proof of residency status by attaching a photocopy of your government issued identification, as listed above.
- If the policy/contract owner is a corporation or other entity, complete form C-0044.
