Which Contract do I need?

- An **individual broker** reports to an MGA or AGA, they are paid directly, and they own their business.
- A **corporate broker** reports to an MGA or AGA, they are paid directly to a corporate account, and they own their business, and the business of any subbrokers.
- A **corporate sub-broker** reports to a corporate broker, is generally on pay transfer to the corporate broker, and they do not own their business.
