We are pleased to announce that effective September 15, 2011, we have made the following enhancements to **Empire Life Portfolio Funds.**

1. Streamlined the underlying fund mixes to improve the long term risk/return profiles

- 2. Added Empire Life Dividend Growth Fund to increase the yield potential
- 3. Increased Canadian exposure to reduce foreign equity and exchange rate risk
- 4. Enhanced the rebalancing approach within a +/- 2.5% band to capitalize on shorter to medium term market trends
