

OHIP+ Update

Transition period for some Exceptional Access Program Drugs (EAP): July 1, 2018 deadline

All Ontario residents age 24 and under who have OHIP coverage are now automatically covered by OHIP+: Children and Youth Pharmacare. As noted in our previous communications, because drug funding decisions under the government EAP can take time, insurers agreed to temporarily assist with coverage from January 1 to June 30, 2018, for the following specific categories of EAP drugs: antibiotics and anti-infectives, blood thinners, and drugs with low EAP approval rates.

Beginning July 1, 2018, these drugs will no longer be eligible for coverage under the private plan unless a plan member's application for coverage under the Exceptional Access Program is denied.

It is important that impacted plan members who may be eligible for funding under the government EAP apply before July 1, 2018.

Plan administrators can send this suggested <u>communication</u> to employees to remind them to apply for EAP funding, if applicable.

Ontario Budget News

On March 28, 2018, the government of Ontario tabled the 2018 Budget. Highlights include a mandate for expansion of health benefits including:

- Free prescription drugs for everyone 65 and over through OHIP+ by eliminating the Ontario Drug Benefit annual deductible and co-pay
- Improved access to mental health and addiction services, including publicly funded psychotherapy
- A new Dental and Drug benefit for those not presently covered by either OHIP+ or an employer benefit plan

Quebec Budget News

On March 28, 2018, the government of Quebec tabled the 2018 Budget. Highlights include a mandate for improving

access to and quality of healthcare, including:

- · Improved access to home care and intermediate care
- Enhanced assistance for seniors
- Adding specialized nurse practitioners to improve access to frontline health care
- Providing each region with a comparable level of access to frontline and specialized services
- Improved health prevention

British Columbia Budget - Employer Health Tax

In its 2018 Budget, British Columbia announced the elimination of Medical Services Plan (MSP) premiums, effective January 1, 2020. It will partially replace lost revenues by introducing a new Employer Health Tax, effective January 1, 2019—one year before the elimination of MSP premiums. Fair PharmaCare deductibles will also be eliminated for low-income families, effective January 1, 2019.

Reversal of Saskatchewan Provincial Sales Tax (PST/RST) on Insurance Premiums

As previously <u>communicated</u>, the Saskatchewan government announced that provincial sales tax (PST) will no longer apply to group life and health insurance premiums including Administrative Services Only arrangements. This is **effective February 26, 2018 and is extended retroactively to August 1, 2017**, the date when insurance premiums became taxable in Saskatchewan.

Retroactive refunds

Empire Life will refund the Saskatchewan PST that was collected on the August 2017 billing statements through to and including March 2018 billing statements. The refund will show as a 'Saskatchewan Tax Adjustment' on the 'Certificate Detail' page of the June billing statements which are sent to plan administrators in May. If a group is no longer with Empire Life, a separate refund cheque will be mailed to the customer.

A <u>communication</u> will be sent to impacted Plan Administrators on May 10th.
